## Invitation for Electronic Bids Chingad Rural Municipality Awalching, Surkhet

1. Chingad Rural Municipality invites electronic bids from Nepalese eligible bidders under National Competitive Bidding procedures.
2. Eligible Bidders may visit PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
3. Bidder Should submit their bid electronically and may download the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document (NRs.3000) in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Electronic bids must be submitted to the office Of Chingad Rural Municipality, Awalching, Surkhet through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12Hr on (2078/02/02). Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13 Hr on 2078/02/02 at the office of Chingad Rural Municipality, Awalching, Surkhet. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs.2,00,000 (Two Lakhs Only), which shall be valid for 30 days beyond the validity period of the bid (i.e. 2078/06/02)
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
