Online bids shall be opened in the presence of Bidders' representatives who choose to attend at **the specified date and time as shown in table below** at the **office of the Rural Municipal Executive, Awalching, Surkhet**. Online Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum of as shown in table below and scanned copy of the bid security in pdf format Should be upload in e-GP system during bid Submission, which shall be valid for 30 days beyond the validity period of the bid (120 days).
